

Terms and Conditions & Assumption of Risk

Gap at Glen Brook is a program for students ages 18-21. We ask our students to be positive community members, active in making meaningful experiences, ready to try new things and face new challenges. Gap at Glen Brook is neither a rehabilitation program nor a place to deal with behavioral or psychological problems. It is a place for independent adults to learn and work together.

Gap at Glen Brook is a program of Camp Glen Brook. Camp Glen Brook is the New Hampshire campus of the Waldorf School of Garden City.

Reservations and Finances. Once an applicant has been accepted into the Gap at Glen Brook program, a \$1,500 deposit is required to reserve their space. We ask that the balance be paid as noted in the *Enrollment Steps* document. Please contact our office to discuss other payment plans if needed.

Refund Policy. Once a participant is accepted to Gap at Glen Brook and has paid their acceptance deposit, there is no refund of the deposit. If notice of cancellation is received within 45 days of the program start date the participant will forfeit the entire tuition. Any participant who leaves the program early will not receive a refund.

If, for whatever reason, the Gap at Glen Brook program is canceled in its entirety, you will receive a full refund.

Course Content. All participants and families are advised to note that course itineraries are subject to change. When changes are made to incorporate student goals and interests, adjust to the health of the group, or made necessary because of foul weather, problems with transportation, or any other unforeseen problem, we will work to structure the course so that it stays true to its original intent.

Course Tuition Includes:

- A communal house for all gap participants - All meals and kitchen equipment - Course and activity fees and materials - Instructor fees - Various adventure equipment rental Not included are personal expenses including medical fees, health insurance, personal items, toiletries etc.

Medical and Evacuation Expenses. It is the responsibility of the student to manage any prescribed medications while on program, including epinephrine and Epi-Pens.

It is the responsibility of the student and the student's family to understand the limits of any medical and evacuation policy, and to provide up-front payment of emergency services if required.

Respectful Behavior. In order to promote a positive environment for all, it is essential that every individual behave in a respectful manner, whether that be with fellow participants or Gap at Glen Brook staff, or others you engage with during your program.

Discrimination, intolerance, harassment, bullying, acts of violence or any behavior that disrupts a positive group environment or puts the health or safety of any participant (including yourself) at risk may result in immediate dismissal from the program.

I understand and agree that Gap at Glen Brook may dismiss me from the Program at any time and at my sole expense for my failure to comply with any of the above. I understand that in the event I am dismissed from the Program for any reason, I waive the right to a refund of any part of my Program cost, and that Gap at Glen Brook may then send me home at my own expense, and that Gap at Glen Brook is not responsible for arranging my transport home.

- If I become ill or incapacitated, Gap at Glen Brook, it and its affiliates, employees and providers may take any action they deem necessary for my safety and well-being, including, but not limited to, securing medical treatment and transporting me home at my own expense. Gap at Glen Brook retains the right, in its sole discretion, to contact my Emergency Contact listed on my enrollment form or other family members or relevant contacts with regard to health issues or any matter whatsoever that relates to my participation in the Program. I understand that this contact may occur without my prior consent and under circumstances where I may disagree with the decision of Gap at Glen Brook to contact such person. In the event of a medical emergency, Gap at Glen Brook will attempt to locate the appropriate treatment to be administered, and I authorize Gap at Glen Brook to do so. Gap at Glen Brook, however, makes no warranty that it will be able to cause effective (or any) emergency treatment to be administered or to be timely administered, and Gap at Glen Brook will not be responsible for monitoring any health care that I may need.
- I hereby give permission to Gap at Glen Brook and its affiliates to provide ongoing health care, to select medical personnel, and to order x-rays, tests or treatment for me during the time I am a Gap Participant. In the event my emergency contact cannot be reached in an emergency, I hereby give permission to the physician selected by Gap at Glen Brook director to hospitalize, secure proper treatment for, and to order injection and/or anesthesia and/or surgery for me. I understand that this form may be photocopied or electronically transmitted for use away from Camp.
- I hereby give permission for my full participation in all Gap at Glen Brook activities and programs including, but not limited to, the following: archery, games and sports, swimming, outdoor skills and nature study, animal care and gardening, work projects, use of power tools and equipment, including, but not limited to, drills, saws and tractors, forging, cooking in a kitchen and over open fire, confidence/challenge ropes course (including high ropes course), rock climbing, canoeing, kayaking and boating, arts and crafts, bicycling, sledding, ice skating, hiking, backpacking, camping, remote wilderness travel, and other generally recognized activities that a camp might offer as a part of a Gap Program. Furthermore, I know

- of no reason, including those of physical or emotional health, to preclude my full participation in all Gap at Glen Brook programs and activities.
- I give the Gap at Glen Brook director, or a person whom the Gap at Glen Brook director appoints, permission to inspect all personal belongings brought to Gap at Glen Brook by me or sent to me while at Gap at Glen Brook. I understand that any items that the Gap at Glen Brook director deems unsafe, unacceptable or inappropriate to the best interests of Gap at Glen Brook will be confiscated. Gap at Glen Brook is not responsible for any property of mine unless it is checked into the Gap at Glen Brook's office safe.
- I hereby agree to release Gap at Glen Brook, and all subsidiaries, affiliates, related foundations and charitable organizations, including, but not limited to, Camp Glen Brook and The Waldorf School of Garden City, along with each of their respective trustees, directors, shareholders, officers, employees, insurers, agents, independent contractors, authorized representatives and volunteers (collectively, "Released Parties") from any and all claims, of any nature (including for attorneys' fees) related in any manner to my participation in the Gap at Glen Brook program, including, but not limited to, any injury, loss, damage to person or property, death, mental anguish, emotional distress, delay or inconvenience in connection with or resulting from acts of God; acts of government; acts of war (declared or undeclared) or civil unrest; insurrection or revolt; strikes or other labor activities; public health issues or emergencies, epidemics, pandemics, plagues, outbreaks of infectious disease, or mass-illness, including, but not limited to, the COVID-19 pandemic; criminal, terrorist or threatened terrorist activities of any kind; structural or other defective conditions in houses, apartments or other lodging facilities (or in any heating, plumbing, electrical or structural problem therein); dangers associated with or bites from animals, insects or pests; sanitation problems; food poisoning; lack of access to or quality of medical care; difficulty in evacuation in case of a medical or other emergency; financial failure or other defaults by suppliers; dangers associated with water-based activities; or any negligent or willful act or failure to act of any third party; or for any other cause beyond the direct control of Gap at Glen Brook, including, but not limited to, any injury, loss or damage from any of the foregoing caused by the negligence of any Gap at Glen Brook employees, agents or representatives.
- Media images or recordings of me made by or authorized by Gap at Glen Brook will become Gap at Glen Brook property and may be used by Camp Glen Brook for brochures, videos, websites, print, or other publicity purposes. Directory information may be compiled and distributed for the private use of Gap at Glen Brook campers and staff.
- HIPAA Compliance Statement: Subject to the emergency exceptions set forth above, I
 understand that my protected health information will be treated confidentially and will only be
 shared with appropriate personnel.
- COVID-19 Waiver. I recognize that, despite the reasonable precautions Gap at Glen Brook may take, there can be no assurance that I I will not contract COVID-19 or any related illness as a result of attending Gap at Glen Brook, or by participating in Gap at Glen Brook activities or socializing with members of the Gap at Glen Brook community. Accordingly, by enrolling in the Gap at Glen Brook Program I acknowledge and fully assume all COVID-19 related risks that may result from my attendance at Gap at Glen Brook, or my participating in Gap at Glen Brook activities or socializing with members of the Gap at Glen Brook community, including illness and death, and I waive any claim that may arise as a result of any such illness or death, including, but not limited to, any claim of negligence by any of the Released Parties, and I covenant not to sue any of the Released Parties in connection with any such waived claim. I also agree that I will do my best to be aware of any COVID-19 related guidelines from time to time issued by the Center for Disease Control and Prevention and other public health

- authorities, and to comply, and (if necessary) have my family comply, with those guidelines and any other health and safety guidelines announced from time to time by Gap at Glen Brook.
- Gap at Glen Brook may be suspended, in its reasonable discretion, as a result of any force
 majeure event, including, but not limited to, any fire, act of God, hurricane, war, governmental
 action, act of terrorism, epidemic, pandemic, health or safety emergency or any other event
 beyond Gap at Glen Brook's control. If such an event occurs, Gap at Glen Brook shall be
 postponed until such time as Gap at Glen Brook, in its sole discretion, may safely reopen.
 During such time, Gap at Glen Brook may, in its reasonable discretion, implement appropriate
 refund policies.
- I understand that a background check, which may be performed by investigators, is being
 performed as part of the process to evaluate me prior to enrollment, due to the fact that
 school children and minors will reside at the camp during the Gap Programs. I hereby fully
 release and discharge Camp Glen Brook or other source providing information from all claims
 and damages arising out of or relating to any investigation of my background for these
 purposes.
